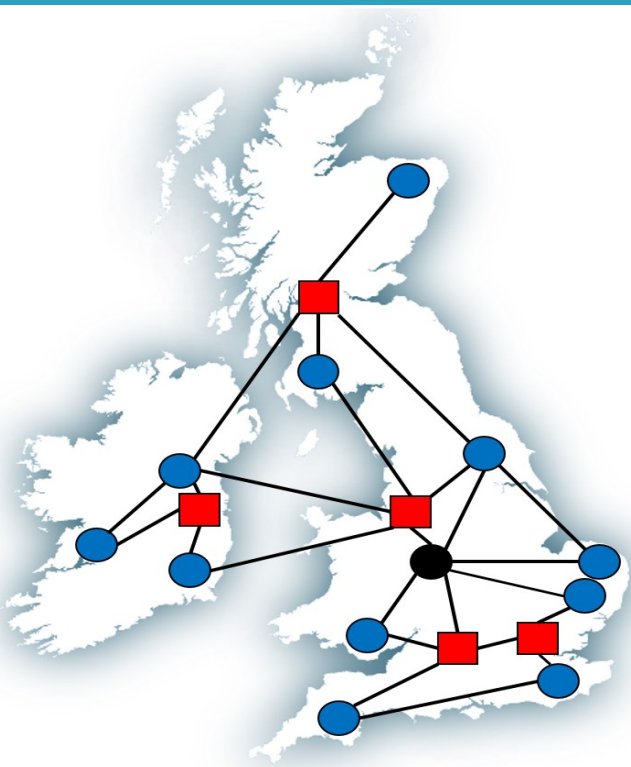

iRetPlat is a collaborative, cross-party, cloud-based platform, specifically designed for organisations who supply produce to customers using returnable transit packaging (RTPs).

iRetPlat provides a dynamic, centralised company-wide platform that records RTP bookings (e.g. automatically via ERP Systems) and also provides a single view of the RTP stock levels and balances at all company sites, 3PL depots, distribution centres and end-customers.

Selected platform “Guests” (i.e. customers) can also be invited to utilise the platform to confirm (or challenge) RTP bookings.

The platform offers an innovative and alternative tool for logistics teams who may use traditional RTP recording methods using paper or Excel.

The platform significantly removes process complexity and digitises and enhances logistical processes and reports.

With iRetPlat, users can instantly view RTP stock-levels at their main site, regional sites 3PL logistics centres PLUS RTP balances with customers and suppliers

The platform saves organisations significant time and effort by reducing the localised manual tasks for recording RTPs exchanges - and digitising/automating the process.

The dynamic platform provides an instant view of RTP stock quantities, qualities, their locations and the balances between partners and third-parties.



Cross Company / Cross Partner Exchange

As the platform is cloud-based, it is potentially accessible by all organisations within the supply chain including:

- Main Site
- Regional Sites
- Third-Party Logistics Partners
- RTP suppliers
- Wholesalers
- End-Customers

iRetPlat users have the authority to grant selected partners the option of “guest” status on their systems to agree on returnable volumes and conditions.

GS1 UK Industry Standards Support

The platform supports all GS1 standards for the transport and logistics industry including:

- GLN (Global Location Number)
- GRAI (Global Returnable Asset Identifier for barcodes)
- RFID (Radio Frequency Identifier)
- EDI (Electronic Data Exchange)

With the returnables platform, organisations can introduce methods of shipments via RFID and this allows organisations to monitor delivery progress throughout the supply chain.

The bookings from SAP/ERP Systems will include the RFID references - the platform will automatically be updated with selected data.

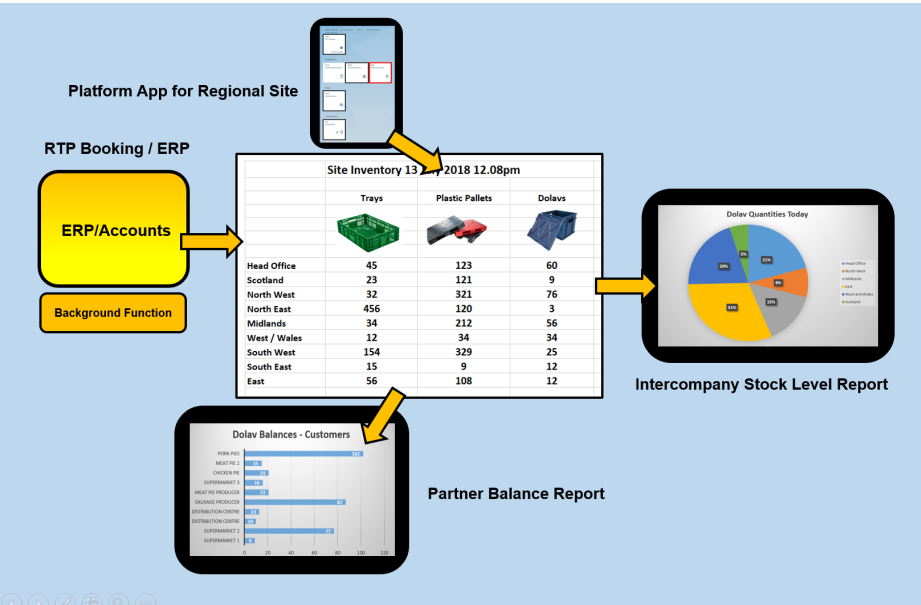
