The application and its benefits

The FIS/fci optimization as part of FIS/edc can be used to automatically enter paper documents or electronic documents, such as PDF documents, in the existing SAP solution. Document characteristics, such as vendor name, address, phone, fax, bank details and tax number, are automatically matched with the master data record in the ERP system.

Excellent recognition rates are achieved using an extensive test methodology. Of course, FIS/fci is suitable for all typical documents in companies, such as invoices, order responses, delivery notes and orders.

FIS/fci application is eInvoicing-compliant

- Due to its enhancement by the SoloIMES component and FIS/InvoiceRefinementService, the FIS/fci application is eInvoicing-compliant. This enables the receipt and forwarding of XRechnung and ZUGFeRD to FIS/edc for invoice receipts.

FIS/fci enhancement by an interface for the new Life Cycle Manager

- FIS/fci was provided with an interface to the new Life Cycle Manager, which is now equipped with data management integrated in SAP. As a consequence, users no longer have to use a Microsoft SQL database for FIS/fci and costs can be saved.

Establishment of a comprehensive backup system

- By installing "MongoDB replica sets", the data processed in FIS/fci is backed up several times. In this way, operating safety is ensured in case of unexpected failures..

Transparency due to SBOM files

- Now, SBOM files are created for FIS/fci customers. They map a safety standard and provide users with an insight into the solution's software components used. As a consequence, security holes can be identified and closed at an early stage.

FIS/fci Cloud application is eInvoicing-compliant

- Due to its enhancement by the SoloIMES component and FIS/InvoiceRefinementService, the FIS/fci application is eInvoicing-compliant. This enables the receipt and forwarding of XRechnung and ZUGFeRD to FIS/edc for invoice receipts.

Further development of AI document recognition

- In order to further optimize the quality of document recognition, "Model 2" was developed, which also identifies item contents now in addition to the layout. Thereby, another qualitative leap was achieved.

Enhancement of recognition process

- Now, documents can run through the recognition software as often as required. In this way, document templates and customer specifics can be further developed and tested in terms of their quality. Here, the objective is to improve the recognition rate once more.

Integration of a "Direct help" function

- By integrating a "Direct help" function, which can be called from the system, the "Help" function in the application could be considerably simplified.

Implementation of the efficient "Rubber band selection" function

- By using the "Rubber band selection" function, document items of a PDF file that were not recognized can easily be selected and transferred to the processing mask, which will result in an efficiency gain.

Setup of multiline fields and dropdowns

- For the processing mask, multiline fields and dropdowns are available now to improve the application's operability.

Improvement of operator guidance

- The operator guidance was improved by using function keys (F3 – Zoom switch, F4 – End of processing, F9 – Delete document, F10 – Write knowledge base).

Adjustment option for batch/document selection list

- The batch and document selection list can now be preconfigured, e.g. individual batches and documents can be assigned to new employees for processing.

Dashboard enhancement

- The FIS/fci dashboard was enhanced by further statistics and evaluations.
