Easier traceability due to automated archiving with the document

- A functionality enabling the archiving of important documents directly with the document in the SAP system has been complemented. This increases the traceability of transmissions and supports users in the fulfillment of obligations to provide evidence for business partners and authorities. Furthermore, the number of log files that have arisen for the obligation to provide evidence can be reduced. This decreases the dataset and increases the clarity of transmission analyses.

Reduced dataset and clearer overview through automated deletion of transmissions, API log messages and status messages

- To reduce the data saved, transmissions, API log messages and status messages can be deleted in an automated way. The time of deletion can be defined in the subsystem according to the element. To prevent transmissions that have to be repeated from getting lost, only completed transmissions with green status will be deleted. The deletion enables a reduction of the dataset, which may reduce costs. Moreover, the overview of troubleshooting or system monitoring becomes clearer.

Easy system monitoring and analysis through dashboard optimization

- The dashboard with its graphical quick filters provides an easy initial access to the evaluation of FIS/xee transmissions. The display in the adjacent charts and the charts below as well as in the table is adjusted accordingly by clicking a bar or making filter settings. This enables a quick and clear overview of summarized information on transmissions.

High usability for the initial creation of partner/message relationships through integrated creation options

- To facilitate the initial creation of partner/message relationships, the required basics, such as business partner, messages or integration scenarios, can be created directly. Consequently, partner/message relationships can also be created, even if one of the basics was forgotten. For the moment, only basic data is entered, which can then be amended in the specific maintenance interface.

Clear overview through improved certificate maintenance

- To enable timely certificate updates, the system automatically informs the user with a message concerning the upcoming expiry. The time when this message is to be displayed can be maintained individually. Besides public certificates, all private certificates are now displayed as well.

Efficient information provision due to data maintenance for objects

- To make the system overview clearer, there is now the option of documenting information directly for business partner, process and transmission. This information can be accessed when a partner/message relationship is created or in the transmission log for instance. Notes can be defined for transmissions that make it easier to retrace an assignment or a transmission status. The process becomes easier to read and understand by adding descriptions to the process arguments. The descriptions defined here are also displayed in the integration scenario.

More flexibility due to an increase of the dataset to be processed

- Now, it is possible to process files larger than 500 MB - 2 GB.

Time-based integration scenarios for reducing manual efforts

- Now, it is possible to start integration scenarios on a time-controlled basis. In this way, retrieval processes can be implemented without a transmission having to be received. Integration scenarios can also be started manually for test purposes.
